No.POWER-2/2011/357- In exercise of the power conferred by Clause (d) of sub-Section (2) of Section 180 of the Electricity Act, 2003 (36 of 2003), the Governor of Meghalaya is pleased to make the following Rules to amend the Meghalaya Electricity Regulatory Commission (Salaries, Allowances and Conditions of service of Chairpersons and other Members) Rules, 2003, namely:-

The Meghalaya Electricity Regulatory Commission (Amendment) Rules, 2017.

## Short title and commencement.

 These rules may be called the Meghalaya Electricity Regulatory Commission. (Salaries, Allowances and conditions of service of Chairperson and other Members) (Amendment) Rules, 2017.

# Amendment of rule 5.

- 2. (i) In rule 5 of the Meghalaya Electricity Regulatory Commission (Salaries, Allowances and conditions of service of Chairperson and other Members) Rules, 2003 (hereinafter referred to as the principal rules) for the words and figures "The Chairperson shall receive a fixed pay of Rs. 80,000/- (Rupees eighty thousand) only plus special allowance of Rs. 1000/- (Rupees eighty thousand) only plus special allowance of Rs. 1000/- (Rupees One thousand) only per month" the words "The Chairperson shall received the pay equivalent to the pay of the Chief Secretary of the State Government" shall be substituted;
  - (ii) the full-stop "." at the end of the rule 5 shall be substituted by colon ":"; and
  - (iii) after rule 5 a proviso shall be inserted as follows:

    "Provided that if the Chairperson at the time of his appointment, was in receipt of, or being eligible so to do, had elected to draw, a pension (other than disability pension) in respect of any previous service under the Central Government or the Government of a State, his salary in respect of the service as a Chairperson shall be reduced,-

(b) if he had, before assuming office, received, in lieu of a portion of the pension due to him in respect of such previous service, the commuted value thereof, by the amount of such portion of the pension".
