ORDER

The Petitioner MePDCL on 05.02.2016 filed its petition for approval of the True up for FY 2013-14, the Provisional True up for FY 2014-15 and for approval of the revision of Tariff and Open access charges for FY 2016-17.

The petitioner on 06.01.2016 also filed a petition for True up for FY 2012-13 and to allow adjustment in the ARR in the True up order dated 31.03.2015 for FY 2011-12. The Commission required some information from the Petitioner vide its letters dated on 18.01.2016 & 20.01.2016. The Petitioner on 09.02.2016 submitted some of the information pertaining to the true up of FY 2012-13.

It also filed on 01.12.2015 a petition for approval of the Business Plan for the MYT control period, i.e., FYs 2015-16 to 2017-18. The Commission did not then consider the petition for want of audited accounts of MePDCL. The Petitioner MePDCL now on 05.02.2016 submitted the audited Statement of Accounts for FY 2013-14 and provisional accounts for FY 2014-15.

The tariff petition has been filed late. To meet the time line for completion of the tariff process, the Commission hereby provisionally admits the above said petitions for further processing. The petitioner, however, shall furnish additional information as may be found necessary during the processing of the petitions.

It is further directed that the petitioner shall publish a public notice in accordance with the Tariff Regulations detailing the salient features of petition for adjustment of true up of FY 2011-12, True up petition for FY 2012-13 and FY 2013-14, the Provisional True up petition for FY 2014-15 & the revision of Tariff and Open access charges for FY 2016-17 and the petition for Business Plan for the control period inviting comments from the stakeholders and the public giving them 30 days' time to respond. In the Public notice, MePDCL shall show the present tariff and proposed tariff clearly for each category including the open access charges. The petitioner shall also place the petitions along with the audited Statement of Accounts for FY 2012-13, FY 2013-14 and the Provisional Statement of Accounts for FY 2014-15 and the Business Plan for FY 2015-16 to FY 2017-18 on its website and shall make available copies of the same at their offices for inspection and taking of relevant extracts thereof by interested parties.
