CORRIGENDUM

(Dated 18th June 2025)

1. This Commission vide its Order Dated 24th March 2025 in MSERC Case No. 09 of 2024, has approved the Revised Aggregate Revenue Requirement for FY 2025-26 & Distribution Tariff for FY 2025-26 for the Meghalaya Power Distribution Corporation Limited (herein referred as 'MePDCL' in the Order).
2. The Commission in the said Order has approved the Open Access Charges in addition to Additional Surcharge payable by the Open Access Consumers vide following tables:
 - i. Page No. 59, Table 56: Approved Wheeling charges for FY 2025-26 (Rs Cr.).
 - ii. Page No. 64, Table 58: Computation of Intra-State Transmission Charges (TC) & Inter-State Charges (PC) for FY 2025-26.
 - iii. Page No. 65, Table 59: Computation of Aggregate of transmission, distribution, and wheeling charges for FY 2025-26 (Rs/kWh).
 - iv. Page No. 65, Table 60: Computation of Cross Subsidy Surcharge for FY 2025-26.
 - v. Page No. 65, Table 61: Computation of Cross Subsidy Surcharge for Ferro Alloy Industries for FY 2025-26.
3. In addition to the above tables, this Commission in the said Order has also approved the Transmission Wheeling Charge of Industrial and Ferro Alloy category in Page No. 74, Table 71
4. That the Commission vide letter No. DCBL/MGH/18/2025-26, dated 12th May 2025, has received a submission from Dalmia Cement Bharat Limited (herein referred as 'DCBL' in the Order), regarding the applicability of the Distribution Wheeling Charges and CTU Charges as approved by the Commission vide Table 59 and Table 71, respectively, of the Order Dated 24th March 2025 in MSERC Case No. 09 of 2024.

5. That, this Commission after due diligence and upon perusal of the submissions made by DCBL, finds that an inadvertent error has crept in the aforementioned Order.
6. Accordingly, the Commission in accordance with the provision under Section 22.2 of the MSERC Multi Year Tariff Regulations, 2014, as reproduced below, and all other powers enabling in this behalf:

“22 Review of Tariff Order

.....

22.2 *On being satisfied that there is a need to review the tariff of any generating company or the licensee, the Commission may on its own initiate process of review of the tariff of any generating company or the licenses. **The Commission may also, in its own motion review any tariff order to correct any clerical error or any error apparent of the face of the record.**”*

7. This Commission hereby undertakes to incorporate certain corrections in respect of the Order dated 24th March 2025 for the Revised Aggregate Revenue Requirement for FY 2025-26 & Distribution Tariff for FY 2025-26 for MePDCL, as follows:
