The Meghalaya State Electricity Regulatory Commission will hold the Public Hearing on the Petitions for Truing up of Business for FY 2024-25 and Approval of Revised Aggregate Revenue Requirement (ARR) for FY 2026-27 and Determination of Tariff for FY 2026-27 filed by Meghalaya Power Generation Corporation Ltd. (MePGCL), Meghalaya Power Transmission Corporation Ltd. (MePTCL) and Meghalaya Power Distribution Corporation Ltd. (MePDCL), in the **State Convention Centre, Shillong-793001**.
